## Clothing Judging and Style Revue Instructions

Hello all! I hope you are having a great summer so far! It is that time of year again that the County Fair is upon us. The Clothing Judging and Style Revue Clothing Judging will be held at the United Methodist Church in Hillsboro, on Tuesday, July 25<sup>th</sup> from 1:00 p.m. to 4:30 p.m. The Public Style Revue will be held at the same location on Tuesday, July 25<sup>th</sup> at 7:00 p.m. Clothing Judging check-in will be from 12:00-12:30 p.m. Please be early to your judging time slots as we may be running ahead at times!

The Clothing Judging Superintendent this year is Michelle Berens with Addie Berens as her Assistant. The Public Style Revue Superintendent this year is Kelli Olson with Kaitlyn Olson as her Assistant. The Clothing Judging Display (inside the 4H Building from Thursday through Saturday) will be set up by Mickie Watson.

Our Style Revue theme this year is, *A Night in Paris!* Please try to email me your scripts by July 21<sup>st</sup> at [tcope@ksu.edu](mailto:tcope@ksu.edu). I will reply that I have received them. If you cannot send your script via email, please bring a printed copy to the judging on Tuesday, July 25<sup>th</sup> at 1:00 p.m. Be sure your name, club, and how many years in the project/and or 4-H are mentioned. You may want to put in your parent's name too. Talk about where you might wear it, maybe a neat story about the process, and what it is made of. Put a catchy sentence at the end so it will be easy for you to remember as that is your cue to exit the stage.

All who are partaking in the Public Style Revue are more than welcome to practice on the stage any time during the afternoon. We will be having a Rehearsal for the Public Style Revue around 5:00 p.m. if you can be there. While practicing, have someone read your script and wear the shoes you will be using the night of the Style Revue. There will be three "turning points" on the stage to help guide you. Please make sure to arrive around 6:45 p.m. to get ready and prepare for the Public Style Revue. Style Revue Purchased and Constructed Clothing will receive their ribbons at this event.

Be sure to know how to care for your garments, cost per wear of the whole outfit, and how it fits into your wardrobe. I have attached a cost per wear sheet just for your use. Stop by the office if you need help filling it out! It would also be a good idea to reference the state score sheets attached for pointers as you will be judged on the listed criteria.

For those who are in Constructed Clothing: The 4-H mall no longer makes clothing labels. Please cut and tack in a 3" by 2 ½" piece of cloth on the inside back neck band, inside back waistband, or another location. Then write your class number, county, and name on the fabric. A sharpie with white or cream cotton type fabric works the best. If an entry has more than one component, attach a label to each part of the exhibit.

If I have made mistakes in the schedule, or you don't see your name where it should be, please contact me as soon as possible!

I hope each of you have a fantastic time with this event! Don't forget to spread the word to have your family and friends join us at the Public Style Revue!
